Where the word "the Club" appears in this agreement, it shall include the club's Board, Board Members, Officers, Employees, Volunteers, Agents, and anyone else acting on behalf of the Club.

I/WE hereby freely accept all these risks, however caused, whether the risks in personal injury, property damage, death, or some other harm to myself / infant.

As a condition of the Club allowing anyone to participate in activities, I/WE agree to waive all claims that anyone may have in the future against the Club and / or the County for any injury, property damage, financial loss, or any other loss that may result in directly or indirectly from my / the infant's participation in the Club activities, no matter how the loss is caused, INCLUDING NEGLIGENCE ON THE PART OF THE CLUB. I understand and voluntarily assume all the inherent risks in the Club including serious injury and death.
